Pursuant to the administrative procedure and implementation of the chicken quota, and in accordance with what is established in Article 11 of Executive Accord 32-2007 dated December 28, 2007 "Regulation on the Distribution and Allocation of the Contingent of Chicken (Thighs, Legs, with some Joined Together), established in the Free Trade Treaty between Central America, the Dominican Republic and the United States," I take this opportunity to inform you that in observance of Article 10 of the aforesaid Regulation, this Secretariat published the Notification of opening so that economic agents interested in importing chicken (Thighs, Legs, with some Joined Together) could submit their applications for registration as importers to the General Secretary of this Secretariat.
